COD shipments are available but must be approved by Hot Products when the order is placed. All COD orders will incur a \$12.50 COD Processing Fee (the actual UPS COD Fee) if the order is not paid via credit card.
Shipping (USA):All orders will be shipped via UPS Ground unless otherwise requested. Hot Products offers free UPS Ground shipping on all orders of \$250.00 or more within the continental USA (Excluding Alaska, Hawaii, Guam, Puerto Rico).The following items are exceptions to the free freight policy and do not qualify: Hydro-Turf Sheets, Hydro-Turf Underpad, Beach Stands, Launcher Totes, Lifesled and other oversized or bulk items. The UPS Ground rate will be credited against the UPS Air Freight charges on all qualifying free UPS Ground orders. *All shipping rates are the published UPS rates. Any shipment that meets the \$250 free shipping policy that is a residential delivery will incur a \$5 fee.
Shipping (Export): Hot Products ships via various carriers and freight forwarding companies to insure the lowest export shipping rates and expedited shipping on all export orders. The Hot Products Free (USA) Shipping Policy does not apply to International/Export orders.
Damaged Shipments: If you receive a shipment and it is damaged you must indicate DAMAGED when you sign for the shipment. KEEP the shipping carton. HOLD the goods. NOTIFY UPS & Hot Products by phone for instructions. Any DAMAGED goods or SHORTAGES MUST be reported within 2 Business Days of date of receiving your order.
Product Overages/ Shortages: If a product is missing or if an extra product is included (but not ordered) please contact Hot Products asap. All overages/shortages must be reported within 2 Business Days of receiving goods. Please have the invoice number and number of packages received available.
Returned Items: All exchanges for wrong items (unopened) must be made within 10 days of purchase with a copy of the original invoice. Please call to request return authorization, all returns require a Return Authorization. All returns are subject to a 15% restocking fee.
Return Checks: All returned checks and refused shipments will result in a \$25.00 processing charge. In addition any returned check will place that account on a Credit Card payment required status. The account must be cleared in full and will be reevaluated before account is returned to a COD status if approved.
